The Department of Pharmacy provides 24/7 services, supported by approximately 50 pharmacy personnel. The hospital has a computerized electronic health record, an automated dispensing system, and decentralized clinical pharmacists.

Located north of Loop 101 and Scottsdale Road, Scottsdale Thompson Peak Medical Center is a 128-bed facility offering state-of-the-art medical, surgical, and emergency care services. The hospital provides intensive care services and cardiac care including cardiac catheterization. Scottsdale Thompson Peak Medical Center is a certified Chest Pain Center and has earned Magnet designation, the highest national designation for excellence in nursing care.
